Dear Sir/Madam,

With reference to your application dated 24.12.97 and subsequent correspondence with the school/inspection in this regard, I am directed to convey provisional approval for Middle Classes Syllabus w. e. f. 01.04.98 to 31.03.2001.

The above sanction is subject to fulfilment of the following conditions :-

1. School shall follow the national syllabus for the middle classes.
2. The grant for approval of syllabus of the Middle Classes does not in any way imply any obligation on the part of the Board to affiliate the Secondary classes.
3. The approval will also be subject to the condition that the school will make a fresh application for provisional affiliation of the Secondary Classes (IX-X) to the Board on the prescribed form in accordance with Rules and Conditions for Provisional Affiliation when class VIII has been started.
4. The school shall appoint only qualified and eligible staff.
5. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
6. Service condition, pay and Allowances and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government school of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
7. The school and its records shall be open for inspection by an official of the Board or an authorised representative of the Board/State Education Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.



8. The rate of tuition fees and other fees charged should be commensurate with the facilities provided.
9. The admission to the school shall be open to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
10. No unrecognised classes shall run within the premises of the school or outside in the same name of school.
11. The school will abide by the rules and conditions for affiliation as given in the Affiliation Bye-Laws of the Board.
12. Code No. allotted to your school is 9665. This may please be noted and quoted in all future correspondence with the Board.
13. Reserve fund be maintained in the joint name of the Chairman, CBSE and the school authorities in accordance with the enrolment in the school from time to time.

Your attention is invited to the following points/deficiencies/observations by the Board's Inspection Committee which inspected your school on 01.08.98. You are requested to make good, fulfil the same and send a definite report positions to the Affiliation Branch of the Board.

14. The approval of Syllabus is only for three years w.e.f. 1.4.98 to 31.3.2001 and it is not extendable and.
15. The school will complete the construction of pucca building before applying for provisional affiliation upto secondary level latest by 31.8.2000, failing which the approval of syllabus for Middle Classes would stand elapsed w.e.f. 01.04.2001.
16. 5-6 names of persons not below the rank of M. Yours faithfully,  
Principal of Sr. Sec. School affiliated with the  
Board be recommended so that two of them may be  
approved by the Board as its nominee in the  
school Managing Committee.

Other conditions:-

Conditions for which compliance are to be submitted within three months of issue of sanction letter.

1. Running/Starting of class - IX/X/~~XI~~/XII without prior provisional affiliation & upto secondary level/Sr. secondary level from the Board would be unauthorised classes and school shall be responsible for the consequences arising out of it.
2. School will not prepare any ~~statement~~ other Board except CBSE from their CBSE affiliated school building/premises.
3. Pay & Allowances to staff should be revised time to time to bring it at par with that to State Govt.
4. The school shall maintain Reserve Fund in the joint names of the Manager of the school concerned and the Chairman of the Board in the Scheduled Bank to the extent indicated below :-

Upto - 500	60,000/-
501 - 750	80,000/-
751 - 1000	1,00,000/-
above - 1000	Rs. 100/- per <sup>student</sup> hundred rounded to nearest thousand.

The interest accruing out of the deposit of reserve fund made by the Institution at the time of affiliation/extension of affiliation be not withdrawn by the Management under any circumstances what so ever.

5. The service conditions be strictly followed as per State Education Act and staff be given appointment/confirmation letters etc. accordingly.
6. 5-6 names of persons not below the rank of Principal of Sr. Sec. School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee.

3. The School shall possess following valid mandatory documents at all times :

  1. Boundary Wall: Concrete boundary wall of not less than 6 ft. height, enclosing the school campus/site. Composite boundary walls which are partly concrete and partly grill/mesh/barbed wire below 6 feet will not be acceptable. If fencing/grill is required, then the same should be over and above 6 feet height.
  2. Ramps at the entrance(s) as well as Ramps/lifts for CWSN, to access the upper floors of the school (in case of a multistoried school) (Circular No. CBSE/AFF-05/2023 dated 06.03.2023).
  3. Separate toilets for CWSN, boys and girls on every floor (in case of multistoried schools) (Circular No. CBSE/AFF-05/2023 dated 06.03.2023).

4. Appropriate laboratory infrastructure for Secondary School (Composite Science Lab, Mathematics Lab, Computer Lab) and for Senior Secondary School (Composite Science Lab, Mathematics Lab, Computer Lab, Physics Lab, Chemistry Lab, Biology Lab.) (Circular no. CBSE/AFF-11/2022 dated 04.10.2022)
5. Well stocked library with adequate reading area. (Circular no. CBSE/AFF-11/2022 dated 04.10.2022)
6. Well-developed indoor and outdoor sports facilities. (Circular no. CBSE/AFF-11/2022 dated 04.10.2022)
7. Well-developed Digital Infrastructure (Circular No. CBSE/AFF-10/2023 dated 24.03.2023)

Failure to comply within the prescribed time may invite financial penalty @ 50,000/- per month until compliance is submitted and may debar the school from filling the registration and LOC of students' class IX to class XII, as the case may be.
